Participants arrive at 9:00am

Auditors arrive at 10:00am

If you are bringing a horse please notify us in advance with date and time of arrival at least 2 days in advance.

### ***List of Things to Bring:***

Balance of fees-payable on day one

Comfy chair if you prefer that to a plastic one

Refillable water bottle (we try to be as green as possible and avoid plastic)

Snacks for midmorning/afternoon. ( A catered lunch will be available for \$12 per day)

Layers of clothing, rain gear, sun screen, hat, & your Piet rope if you have one

### ***If Bringing a Horse:***

Negative Coggins Cert & vaccination information (E-mailed is preferable)

Hay, Feed (in marked baggies), Water bucket for stall and/or tub for paddock (I have extra tubs if you need one) Fly mask & spray

### ***Indoor Reserved for Inclement Weather:***

You will be notified if the venue changes due to inclement weather. We will be at Stage Road Farm-228 Stage Road in Guilford, Vermont. Here are the directions:

Turn onto Center Rd in Guilford like you are going to my farm. Drive 4.6 miles and turn/bear right onto Stage Rd. The farm is at 228 Stage Road. It's about .2 miles down on the right. Follow driveway around pond and across bridge to the indoor arena. Stage Road is approximately 3 miles past my road-Weatherhead Hollow.
